



# INVITATION EUROPE 2020 MIDTERM REVIEW: WHAT TRACK RECORD? WHAT OPPORTUNITIES?

Eurodiaconia is pleased to invite its members to a **training seminar on the European semester and the Europe 2020 strategy**, in the context of the Europe 2020 midterm review. It will take place in Brussels from 25<sup>th</sup> to 26<sup>th</sup> September 2014.

The Europe 2020 strategy<sup>1</sup> and the European Semester<sup>2</sup> have been guiding the European Union overarching policies over the past four years. Eurodiaconia and has participated in the process at national and European levels. But four years on, where are we? Where is the strategy going?

The Europe 2020 midterm review is taking place now. It started with the European Commission Communication <u>"Taking stock of the Europe 2020 strategy for smart, sustainable and inclusive growth"</u> on 5<sup>th</sup> March 2014, and is continuing with <u>the public consultation on the Europe 2020 strategy</u> (from 5 May 2014 to 31 October 2014). It is a very special opportunity to:

- 1) reflect on the impact of the strategy and its design for the future,
- 2) share Eurodiaconia's members experience and assessment of the process,
- 3) get up to speed on the existing European governance mechanism and how to use them as policy hooks at national level,
- 4) imagine and propose a model for stakeholders' involvement.

This is the background of Eurodiaconia's training on the Europe 2020 strategy and the European Semester. The meeting will bring together Eurodiaconia members with expertise of the European Semester process at national level, as well as external contributions from institutional actors (European Commission and European Parliament). Together participants will work to develop their understanding of the Europe 2020 strategy and European Semester process in order to increase their capacity for engagement and ownership of the process.

Participants will also work on an assessment of the (forthcoming) June 2014 Country Specific Recommendations and a midterm assessment of the Europe 2020 strategy; as well as looking forward in developing the basis for a model of stakeholders involvement.

<sup>&</sup>lt;sup>1</sup>The Europe 2020 strategy is the European Union's strategy for smart, sustainable and inclusive growth for 2010-2020. It aimed to achieve a knowledge-based, competitive European economy while preserving the EU's social market economy model and improving resource efficiency. To do so, it aimed to achieve five quantitative targets in the areas of employment, research and development, climate and energy, education and the fight against poverty and social exclusion. The strategy also relied on seven "flagship initiatives" in the areas of innovation, the digital economy, employment and youth, industrial policy, poverty and resource efficiency.

<sup>&</sup>lt;sup>2</sup> The European Semester is a yearly cycle of economic policy coordination, established by the European Commission to facilitate the coordination of Member States national policies and the attainment of the Europe 2020 objectives.
