Review of 2023

The review of 2023 consists of 2 elements – the Annual Report of 2023 which you will have received as an attachment in advance of the AGM. Members are invited to review the Annual Report and pose any questions that may arise. The second element is the financial report which can be found below and in the Annual Report and also in the two annexes to this document, the first being the 2023 accounts in the standard Belgian reporting system (in French) and the report from our auditors.

Finance report 2023

2023 was a solid financial year with no major changes in Income and Expenditure and a surplus at the end of the year of €37k. Income was slightly higher than budget due to greater attendance at the AGM, some additional fees and membership contributions and a slightly higher than planned project grant.

Expenditure on salaries was slightly lower than foreseen due to some long-term staff absences. Activities were to budget but we spent more on administration and services than originally foreseen which links to the higher costs of many goods and services in 2023.
